5. Copy of Ration Card and Aadhar card as proof for permanent resident in Chandigarh.
6. Birth Certificate of the applicant.
7. Disability Certificate.
8. Copy of Bank account detail(Bank account must be in the name of student only)



The eligible students may apply through online on the website of common National Scholarship portal of Govt. of India under URL [www.scholarships.gov.in](http://www.scholarships.gov.in) as per above given time line. It may be ensured that the students whose annual Fees is less than Rs. 50000/- has no need to upload any documents on the web portal and the student whose fee is more than Rs.50000/- has need to upload all the documents on the NSP portal. It may also be ensured that the students will take printouts of the duly filled application forms and submit along with all supporting documents (i.e. residence proof, last class pass certificate, Aadhaar no., bank account in the name of applicant, income proof Minority certificate/Affidavit) in their respective institutes. It will be necessary for the applicants to provide Aadhaar number/Aadhaar Enrolment ID while applying for the scholarship. Institutes are suggested to verify the applications of the students on NSP portal using their institute User ID and Password, well in time.
